RESOLUTION TO AMEND BUDGET

RESOLUTION OF THE MOUNTAIN’S EDGE METROPOLITAN DISTRICT TO AMEND THE 2024 BUDGET

Pursuant to Section 29-1-109, C.R.S., the Board of Mountain’s Edge Metropolitan District (the “**District**”), hereby certifies that a regular meeting of the Board of Directors of the District, was held on November 9, 2023, via video and telephone conference through Microsoft Teams.

A. At such meeting, the Board of Directors of the District adopted that certain Resolution No. 2023-11-03 to Adopt Budget appropriating funds for the fiscal year 2024 as follows:

General Fund	\$215,000
Special Revenue Fund	\$0
Debt Service Fund	\$200,000

B. The necessity has arisen for additional Special Revenue Fund appropriations requiring the expenditure of funds in excess of those appropriated for the fiscal year 2024.

C. The source and amount of revenues for such expenditures, the purposes for which such revenues are being appropriated, and the fund(s) which shall make such supplemental expenditures are described on **Exhibit A**, attached hereto and incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the Mountain’s Edge Metropolitan District shall and hereby does amend the budget for the fiscal year 202 as follows:





Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
